You are requested to kindly circulate this memo on behalf of Respondent No. 4 (National Law School of India University, Bangalore) before the Hon'ble Judges:

1. As submitted before this Hon'ble Court on 08.03.2021, the Respondent No. 4 University, in consultation with its Governing Bodies, has developed a new policy to deepen and increase diversity of its student body and facilitate greater access to various marginalized and/or underprivileged sections of society. This "NLSIU Inclusion and Expansion Plan 2021-2024" ("the Plan") provides for additional reservation categories for admission to the Respondent No. 4 University, including for Karnataka students.
2. The Executive Council of the Respondent No. 4 University had reviewed and affirmed the Plan at its meeting dated 21.03.2021 and placed the Plan before the General Council of the Respondent No. 4 University for its advice and recommendations.
3. Accordingly, on 17.04.2021, the General Council reviewed and discussed the plan and accepted and recommended that the Respondent No. 4 University implements the Plan.
4. Hence, *inter alia* reservation for Karnataka students will be implemented at the Respondent No. 4 University from academic year 2021-22. The Respondent No. 4 University brings this matter to the attention of this Hon'ble Court for further consideration.
